



2s Parent and Child Playgroup

Chelsea Children's Cooperative Preschool is excited to offer a 2-year-old Parent and Child Playgroup. The 2-year-old program provides families with a parent-child activity for the child who is not quite old enough to attend the traditional preschool. It also gives parents a means to connect with other parents as well as provide some "preschool experience" to both parent and child so that the transition to the 3-year-old preschool will be less intimidating. Parents and children stay for the entire class.

The 2s Playgroup Experience--

At the 2s playgroup, children and their parent, grandparent, or other significant adult gather for a brief casual group time filled with music, laughter, and movement. Along with a traditional "Hello Song," other songs and fingerplays are repeated frequently to promote learning and the security that repetition brings to the daily routine. In addition, new material that relates to our weekly topic is added to spark interest and curiosity. It's important to note that not all children are ready for this "structured" part of our program and that's perfectly okay. Children are free to play and will join the rest of the group when ready. After gathering time, children can work on a simple art project, squish playdough, read books, play with toys and each other, or eat snack. While adults assist with activities, there is ample opportunity to network with each other. This time period usually lasts about one hour. Gathering back together again, we read a short story and bid everyone farewell with a "Good-bye Song".

Enrollment, Tuition, and Registration--

Children enrolling in the 2-year-old playgroup must be 2 years old by September 1st of the school year. We will have two 12-week sessions at the cost of \$80.00 per session. The first session will run October through January and the second will run January through April. Classes are held on Friday mornings from 9:15 - 10:45 AM in classroom 405 at the WSEC.

If you are interested in joining this program, please mail or deliver the completed and signed application along with a \$20.00 deposit, per 12-week session. Your \$20.00 deposit is non-refundable and will be applied towards your \$80 tuition. The remaining tuition is due before the session begins.

We accept members on a first come, first serve basis. If a session is full, your child can be placed on a waitlist for the first available opening. Participating in the 2-year-old program will provide you priority enrollment for the following school year .
